### **REQUIREMENTS:**

- Entry form, submitted works and nonrefundable entry fee due Friday, July 3, 2020 by 4pm.
- Email submitted artwork in JPG format with max 1200 pixels on longest side to director@bowenarts.org.
- Fee: \$15 per work, or \$40 for 3 works. Pay online via PayPal at bowenart.org, via mail with check payable to **The Bowen, P.O. Box 849, Dawsonville, GA 30534** or hand deliver to 334 Highway 9N, Dawsonville, GA.
- 2D Size Limits: Maximum frame size not to exceed 48" in either width or height.
- Hanging works submitted must have securely fastened hanging wire or suitable hanger according to
  materials (such as metal, canvas, etc.) which are compatible with Bowen wall hanging system. The Bowen
  reserves the right to refuse the display of any unsafe or unsuitable work.

### ELIGIBILITY:

- Open to all women residents of Georgia.
- Artists working in all 2D and 3D media are invited to participate.
- Originality: all submissions must be original works in concept, composition, and execution by the artist. Classroom/workshop pieces, copies of master works or any other artwork created under the supervision of an instructor are not eligible. Artwork must not be copied, in part or wholly, from any published or copyrighted work. No reproductions or copies will be accepted.
- Works must have been created in the last four (4) years, and not previously shown in any Pen Women or Bowen exhibitions. Artwork label with artist & title should be affixed to the back or bottom of each piece.
- Artwork presented for the exhibition must be identical work as submitted for entry via email. If not, the work and the artist will be automatically removed from exhibition.
- Artists who do not adhere to these rules will forfeit entry fees and be disqualified from future exhibitions for the next two shows.

SHIPPING: Shipped artwork must arrive no later than July 28, 2020, and sent via UPS or FedEx to street address for The Bowen, 334 Highway 9 North, Dawsonville, GA 30534. Artist must also enclose a prepaid return shipping label. Air Float shipping boxes are recommended. The original packaging will be retained by Bowen for return shipping to artist.
