Eligibility:

- Open to photographers of all ages.
- Enter up to five (5) original photographs per entrant/photographer.
- Entry fee: \$10 per work.
- Photographic entries must be original images captured by the entrant/photographer.
- Entries can be digital manipulations of original photographs as performed by entrant/photographer. Prints on all media such as canvas, metal, paper are acceptable. No size limitations.
- The Bowen and Show Judge have final authority on eligibility, criteria, and choice of entries exhibited in Show.

Requirements:

- **DEADLINE** to email submitted digital images (JPG) by **Tuesday April 30, 2024, 11:59pm** to director@bowenarts.org. Entry form and nonrefundable entry fee must be received or postmarked by April 30, 2024.
- Entry fee: \$10.00 per work, pay online at bowenarts.org or via cash or check payable to **The Bowen, PO Box 849, Dawsonville, GA 30534** or Hand Deliver to Bowen, 334 Highway 9N, Dawsonville, GA 30534.
- All information given on entry form as to title, size and price must remain same on accepted entry.
- Approved work must be framed and securely fastened with hanging wire (no saw tooth hangers), or suitable hanger according to materials (metal, canvas, etc.) compatible with Bowen wall hanging system. The Bowen reserves the right to refuse the display of any unsafe or unsuitable work.

Notification: Artists will be notified via email no later than May 2, 2024 of works that have or have not been accepted. Additional instructions on artwork drop-off dates, etc. will be provided at that time.

Gallery Sales: The Bowen collects 30% commission on all works sold during Show. A 7% Georgia sales tax will be added at point of sale. Prices listed on the entry form are binding. Works not for sale should be listed "NFS."
